Guzman, M.D. ("Physician"), elects to permanently waive any right to a 8 hearing and appeal with respect to this Order for Practice Limitation; admits the jurisdiction 9 of the Arizona Medical Board ("Board"); and consents to the entry of this Order by the 10 Board. 11 FINDINGS OF FACT 12 The Board is the duly constituted authority for the regulation and control of 1. 13 the practice of allopathic medicine in the State of Arizona. 14 Physician is the holder of License No. 35714 for the practice of allopathic 2. 15 medicine in the State of Arizona. 16 Physician has recognized that he has a medical condition that may limit his 3. 17 ability to safely engage in the practice of medicine. 18 There has been no finding of unprofessional conduct against Physician. 4. 19 CONCLUSIONS OF LAW 20 1. The Board possesses jurisdiction over the subject matter hereof and over 21 Physician. 22 **ORDER** 23 IT IS HEREBY ORDERED THAT: 24 1. Physician's practice is limited in that he shall not practice more than 25 hours 25

in a work week until Physician applies to the Board for modification or termination of this limitation. The Board may require, at the Physician's expense, any combination of staff approved assessments, evaluations, treatments, examinations or interviews it finds necessary to assist in determining whether Physician is able to safely resume full time practice.

- 2. Respondent shall immediately provide a copy of this Order to all employers, hospitals and free standing surgery centers where Respondent currently has or in the future gains or applies for employment or privileges. Within 30 days of the date of this Order, Respondent shall provide Board staff with a signed statement of compliance with this notification requirement.
- 3. The Board retains jurisdiction and may initiate a separate disciplinary action based on the facts and circumstances that form the basis for this practice limitation or any violation of this Consent Agreement.

- 5. All admissions made by Physician are solely for final disposition of this matter and any subsequent related administrative proceedings or civil litigation involving the Board and Physician. Therefore, said admissions by Physician are not intended or made for any other use, such as in the context of another state or federal government regulatory agency proceeding, civil or criminal court proceeding, in the State of Arizona or any other state or federal court.
- 6. Upon signing this agreement, and returning this document (or a copy thereof) to the Board's Executive Director, Physician may not revoke the consent to the entry of the Order. Physician may not make any modifications to the document. Any modifications to this original document are ineffective and void unless mutually approved by the parties.
- 7. This Order is a public record that will be publicly disseminated as a formal **non-disciplinary** action of the Board.
- 8. If any part of the Order is later declared void or otherwise unenforceable, the remainder of the Order in its entirety shall remain in force and effect.
- 9. Any violation of this Order constitutes unprofessional conduct and may result in disciplinary action. A.R.S. § § 32-1401(27)(s) ("[v]iolating a formal order, probation,
