**ORDER FOR SURRENDER OF  
LICENSE AND CONSENT TO THE  
SAME**

**(Non-Disciplinary)**

7 Robert A. Mackin, M.D. ("Respondent"), elects to permanently waive any right to a  
8 hearing and appeal with respect to this Order for Surrender of License; admits the  
9 jurisdiction of the Arizona Medical Board ("Board") as well as the facts stated herein; and  
10 consents to the entry of this Order by the Board.

11 **FINDINGS OF FACT**

12 1. The Board is the duly constituted authority for the regulation and control of  
13 the practice of allopathic medicine in the State of Arizona.

14 2. Respondent is the holder of license number 17570 for the practice of  
15 allopathic medicine in the State of Arizona.

16 3. The Board initiated case number MD-21-0118A after receiving a report  
17 indicating that Respondent may have a health condition that impairs his ability to safely  
18 practice medicine.

19 4. Respondent has retired from the practice of medicine, and his license  
20 expired effective September 28, 2022, but the expiration is stayed pending the outcome of  
21 this Board's investigation pursuant to A.R.S. § 32-3202

22 **CONCLUSIONS OF LAW**

23 1. The Board possesses jurisdiction over the subject matter hereof and over  
24 Respondent.

1           5. All admissions made by Respondent are solely for final disposition of this  
2 matter and any subsequent related administrative proceedings or civil litigation involving  
3 the Board and Respondent. Therefore, said admissions by Respondent are not intended  
4 or made for any other use, such as in the context of another state or federal government  
5 regulatory agency proceeding, civil or criminal court proceeding, in the State of Arizona or  
6 any other state or federal court.

7           6. Upon signing this agreement, and returning this document (or a copy  
8 thereof) to the Board's Executive Director, Respondent may not revoke the consent to the  
9 entry of the Order. Respondent may not make any modifications to the document. Any  
10 modifications to this original document are ineffective and void unless mutually approved  
11 by the parties.

12           7. This Order is a public record that will be publicly disseminated as a formal  
13 non-disciplinary action of the Board and will be reported to the National Practitioner's Data  
14 Bank and on the Board's web site as a disciplinary action.

15           8. If the Board does not adopt this Order, Respondent will not assert as a  
16 defense that the Board's consideration of the Order constitutes bias, prejudice,  
17 prejudgment or other similar defense.

18           9. ***Respondent has read and understands the terms of this agreement.***
