**ORDER FOR SURRENDER OF
LICENSE AND CONSENT TO THE
SAME**

7 Lindsay A. Regali, M.D. ("Respondent"), elects to permanently waive any right to a
8 hearing and appeal with respect to this Order for Surrender of License; admits the
9 jurisdiction of the Arizona Medical Board ("Board") as well as the facts stated herein; and
10 consents to the entry of this Order by the Board.

11 **FINDINGS OF FACT**

12 1. The Board is the duly constituted authority for the regulation and control of
13 the practice of allopathic medicine in the State of Arizona.

14 2. Respondent is the holder of license number 67946 for the practice of
15 allopathic medicine in the State of Arizona.

16 3. The Board initiated case number MD-24-0436A after receiving notification
17 that Respondent's clinical privileges at a Hospital in Virginia had been suspended due to
18 concerns that Respondent may have a health condition that impaired her ability to safely
19 practice medicine.

20 4. Based on the report, the Executive Director issued a Confidential Interim
21 Order for Physician Health Program Assessment, which required Respondent to complete
22 a Physician Health Program ("PHP") Assessment within 10 days from the date of the
23 Order.

24 5. Respondent advised that she would be unable to complete the Assessment
25 in a timely manner, and requested an Interim Practice Restriction in lieu of completing the
Assessment.

1 6. Respondent entered into an Interim Consent Agreement for Practice
2 Restriction effective June 10, 2024.

3 7. Respondent did not undergo the PHP Assessment as required by the Interim
4 Order, and has requested surrender of licensure based on her decision not to practice
5 medicine in Arizona.

6 **CONCLUSIONS OF LAW**

7 1. The Board possesses jurisdiction over the subject matter hereof and over
8 Respondent.

9 2. The conduct and circumstances described above constitute unprofessional
10 conduct pursuant to A.R.S. § 32-1401(27)(s) (“Violating a formal order, probation, consent
11 agreement or stipulation issued or entered into by the board or its executive director under
12 this chapter.”).


13 3. The Board possesses statutory authority to enter into a consent agreement
14 with a physician and accept the surrender of an active license from a physician who
15 admits to having committed an act of unprofessional conduct. A.R.S. § 32-1451(T)(2).

16 **ORDER**

17 IT IS HEREBY ORDERED THAT Respondent immediately surrender License
18 Number 67946, issued to Lindsay A. Regali, M.D., for the practice of allopathic medicine in
19 the State of Arizona, and return her certificate of licensure to the Board.

1 **CONSENT TO ENTRY OF ORDER**

2 1. Respondent has read and understands this Consent Agreement and the
3 stipulated Findings of Fact, Conclusions of Law and Order ("Order"). Respondent
4 acknowledges she has the right to consult with legal counsel regarding this matter.

5 2. Respondent acknowledges and agrees that this Order is entered into freely
6 and voluntarily and that no promise was made or coercion used to induce such entry.

7 3. By consenting to this Order, Respondent voluntarily relinquishes any rights
8 to a hearing or judicial review in state or federal court on the matters alleged, or to
9 challenge this Order in its entirety as issued by the Board, and waives any other cause of
10 action related thereto or arising from said Order.

11 4. The Order is not effective until approved by the Board and signed by its
12 Executive Director.

13 5. All admissions made by Respondent in this Order are solely for final
14 disposition of this matter and any subsequent related administrative proceedings or civil
15 litigation involving the Board and Respondent. Therefore, said admissions by Respondent
16 are not intended or made for any other use, such as in the context of another state or
17 federal government regulatory agency proceeding, civil or criminal court proceeding, in the
18 State of Arizona or any other state or federal court.

19 6. Notwithstanding any language in this Order, this Order does not preclude in
20 any way any other State agency or officer or political subdivision of this state from
21 instituting proceedings, investigating claims, or taking legal action as may be appropriate
22 now or in the future relating to this matter or other matters concerning Respondent,
23 including but not limited to, violations of Arizona's Consumer Fraud Act. Respondent
24 acknowledges that, other than with respect to the Board, this Order makes no
25 representations, implied or otherwise, about the views or intended actions of any other

1 state agency or officer or political subdivisions of the State relating to this matter or other
2 matters concerning Respondent

3 7. Upon signing this agreement, and returning this document (or a copy
4 thereof) to the Board's Executive Director, Respondent may not revoke the consent to the
5 entry of the Order. Respondent may not make any modifications to the document. Any
6 modifications to this original document are ineffective and void unless mutually approved
7 by the parties.

8 8. This Order is a public record that will be publicly disseminated as a formal
9 disciplinary action of the Board and will be reported to the National Practitioner's Data
10 Bank and on the Board's web site as a disciplinary action.

11 9. If the Board does not adopt this Order, Respondent will not assert as a
12 defense that the Board's consideration of the Order constitutes bias, prejudice,
13 prejudgment or other similar defense.

14 10. ***Respondent has read and understands the terms of this agreement.***
